



# **Bits and Pieces**

- The U.S. women's hockey team is threatening to boycott the International lce Hockey Federation tournament, scheduled for the end of March, in an effort to spur USA Hockey to engage in fair pay negotiations. This boycott comes on the heels of the U.S. women's national soccer team's efforts to end wage discrimination by the U.S. Soccer Federation.
- With longer life expectancies and higher out-of-pocket health costs, retired women face financial crises that are compounded by the gender pay gap. Retirement specialists advise women to play an active role in their retirement plans to avoid financial ruin.
- Actress Patricia Arquette and UN Women are launching the Equal Pay Platform of Champions, a campaign designed to end the 23 cent global pay gap. The Platform of Champions aims to raise awareness and increase political support to end pay inequality. Follow the campaign online by using the hashtag #stoptherobbery.
- In the wake of U.S. Secretary of Homeland Security John Kelly's statement that the administration is considering a new policy of separating families that attempt to enter the United States across the southern border, the Center for American Progress has estimated that this policy will cost taxpayers \$327 million per year. This cost is in addition to the moral impropriety of separating children from parents, who are often single mothers, as a means to deter immigrants fleeing poverty and violence.
- In the wake of the release of a portion of his 2005 tax return, the White House confirmed that President Trump paid \$38 million in taxes on an

income of \$150 million. The document showed that the majority of the president's tax payment came as a result of the alternative minimum tax, which he is seeking to end.

• Senate Democrats released a list of over 100 oversight letters that the Trump administration has not yet answered. The senators aim to create more accountability and transparency from the administration by compiling the unanswered congressional inquiries.
